Make a Pledge:

Donate Securities:

Gifts of stock are welcomed. Donors can receive a charitable tax deduction for the fair market value on the day the stock is received by FGER. To avoid capital gains taxes, the donor must transfer the stock to FGER and not the proceeds of a sale. Please contact FGER for specific instructions on stock transfers for you and your broker.

Donor Advised Funds:

Gifts through Donor Advised Funds are welcomed. You will need the charity tax ID of FGER and the address to process the gift. The charity tax ID (EIN) is: 91-6063843. The mailing address and phone number are listed below.

Donating through an IRA with a Qualified Charitable Distribution (QCD):

Direct distributions from an IRA to FGER can often be a very tax-efficient way to donate by reducing taxable income and giving an entirely tax-free gift to FGER. Please consult your advisor for the most up-to-date amounts and rules.

Honorary and Memorial Gifts:

Any gift can be made "in honor of" or "in memory of" another person. Please consider honoring a professor, staff, or other person who made JIRP the special program it is, or someone on whom JIRP made an impact on.

Planned Giving:
